# 1. General description

The 74LVT162245B is a high-performance BiCMOS product designed for  $V_{CC}$  operation at 3.3 V.

This device is a 16-bit transceiver featuring non-inverting 3-state bus compatible outputs in both send and receive directions. The control function implementation minimizes external timing requirements. The device features an output enable input ( $n\overline{OE}$ ) for easy cascading and a direction input (nDIR) for direction control.

The 74LVT162245B is designed with 30  $\Omega$  series resistance in both the HIGH-state and LOW-state of the output. This design reduces line noise in applications such as memory address drivers, clock drivers and bus transceivers and transmitters.
















Fig. 9. Package outline SOT362-1 (TSSOP48)
