








 $V_{\text{OL}}$  and  $V_{\text{OH}}$  are typical voltage output levels that occur with the output load.

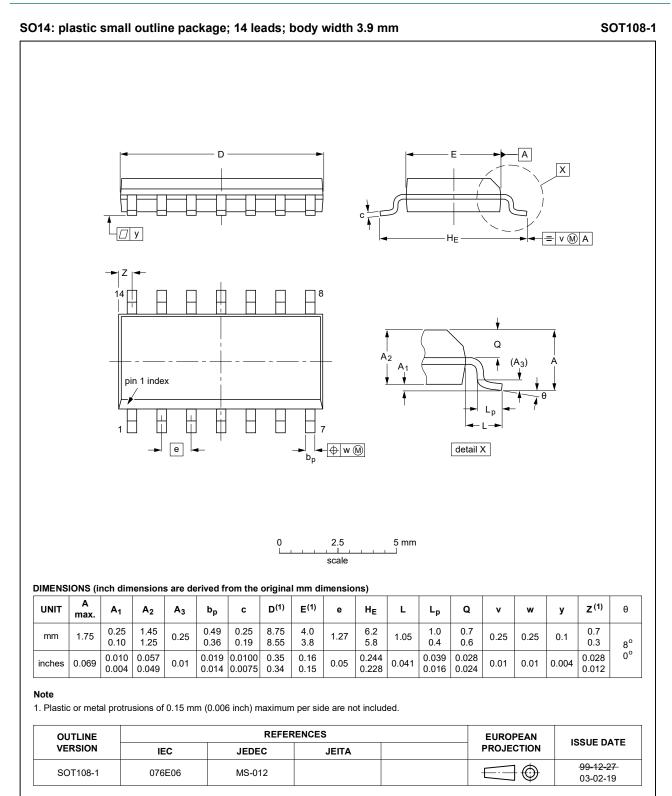

### Fig. 8. Package outline SOT108-1 (SO14)




Fig. 9. Package outline SOT402-1 (TSSOP14)
