1. General description

The 74LVC1G332 is a single 3-input OR gate. Inputs can be driven from either 3.3~V or 5~V devices. This feature allows the use of these devices as translators in mixed 3.3~V and 5~V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




5. Functional diagram








Fig. 10. Package outline SOT363-2 (TSSOP6)




Fig. 11. Package outline SOT457 (SC-74; TSOP6)




Fig. 12. Package outline SOT886 (XSON6)




Fig. 13. Package outline SOT1115 (XSON6)




Fig. 14. Package outline SOT1202 (XSON6)




Fig. 15. Package outline SOT1255 (X2SON6)
