### 1. General description

The 74HC08-Q100; 74HCT08-Q100 is a quad 2-input AND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .







#### 10.1. Waveforms and test circuit





### Fig. 7. Test circuit for measuring switching times

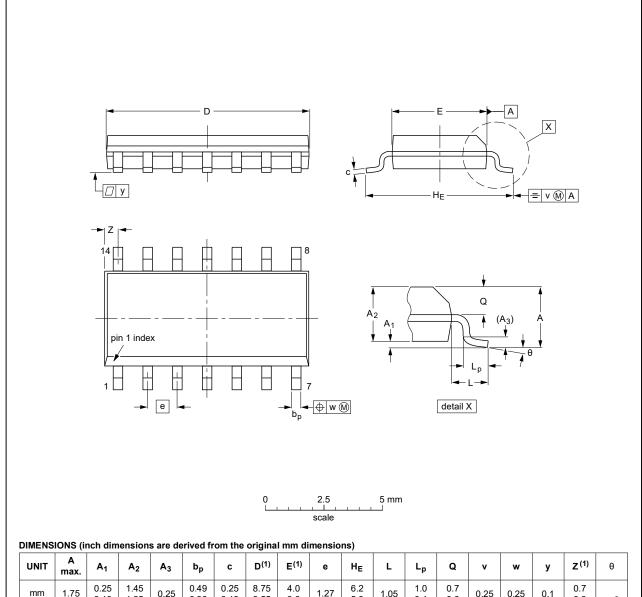

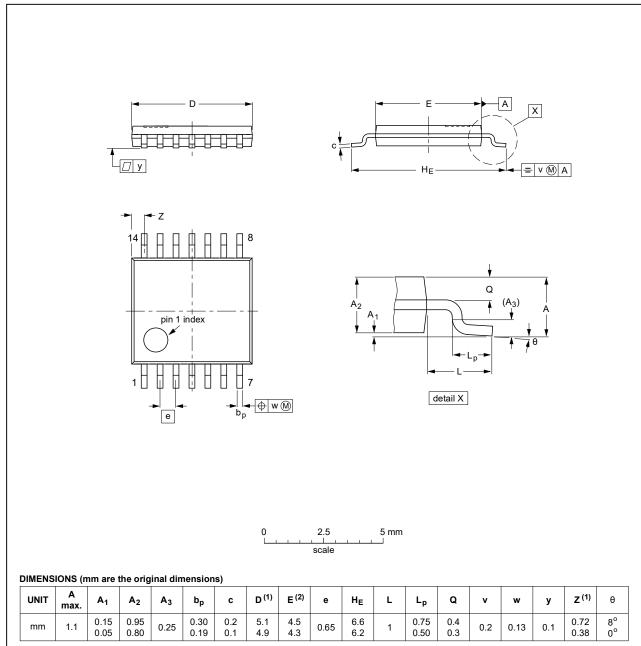

Fig. 9. Package outline SOT402-1 (TSSOP14)




Fig. 10. Package outline SOT762-1 (DHVQFN14)
