#### DESCRIPTION


This device is designed for 1.65-V to 5.5-V  $V_{\rm CC}$  operation.

The SN74LVC1G3208 device is a single 3-input positive OR-AND gate. It performs the Boolean function  $Y = (A + B) \cdot C$  in positive logic.

By tying one input to GND or  $V_{CC}$ , the SN74LVC1G3208 device offers two more functions. When C is tied to  $V_{CC}$ , this device performs as a 2-input OR gate (Y = A + B). When A is tied to GND, the device works as a 2-input AND gate (Y = B  $\bullet$  C). This device also works as a 2-input AND gate when B is tied to GND (Y = A  $\bullet$  C).

NanoStar<sup>™</sup> and NanoFree<sup>™</sup> package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{\rm off}$ . The  $I_{\rm off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.






Figure 1. 2-Input AND Gate




Figure 2. 2-Input OR Gate







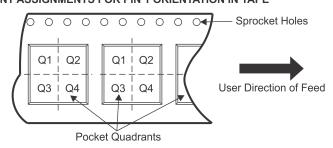
