DESCRIPTION


This triple Schmitt-trigger inverter is designed for 1.65-V to 5.5-V V_{CC} operation.

The SN74LVC3G14 contains three inverters and performs the Boolean function $Y = \overline{A}$. The device functions as three independent inverters but, because of Schmitt action, it may have different input threshold levels for positive-going (V_{T+}) and negative-going (V_T) signals.


NanoFree[™] package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.






