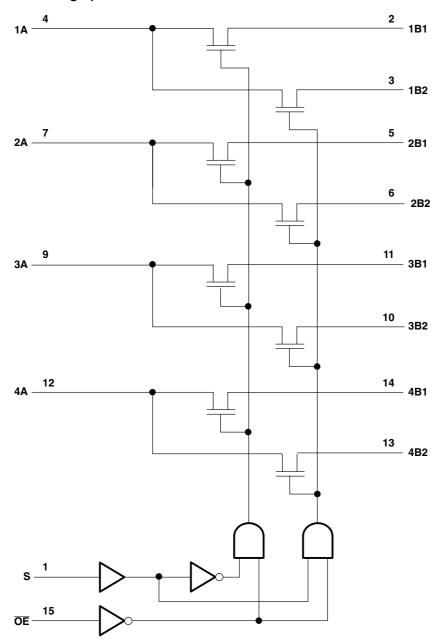

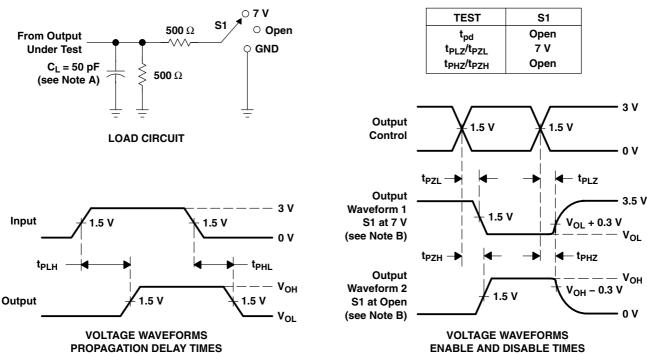

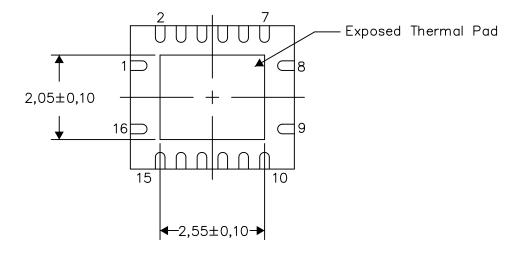

Exposed Thermal Pad Dimensions

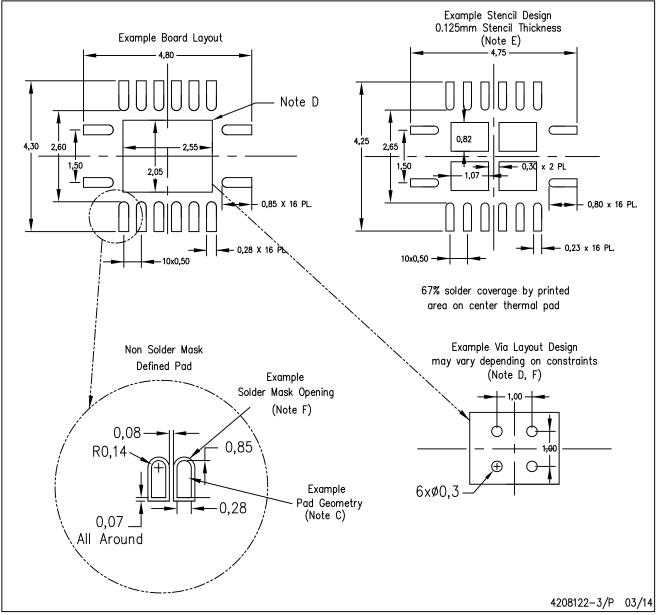
