



Figure 1. Differential and Common-Mode Output Voltages



#### Figure 2. Differential-Output Test Clrcuit and Voltage Waveforms




#### Figure 3. Test Circuit and Voltage Waveforms

### Figure 4. Test Circuit and Voltage Waveforms




