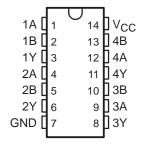

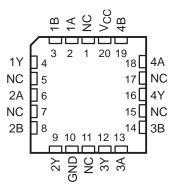

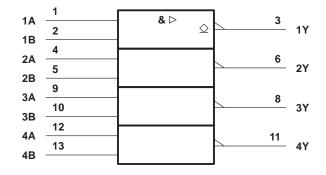


SN54ALS38B . . . FK PACKAGE (TOP VIEW)

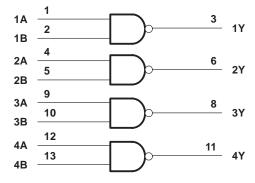

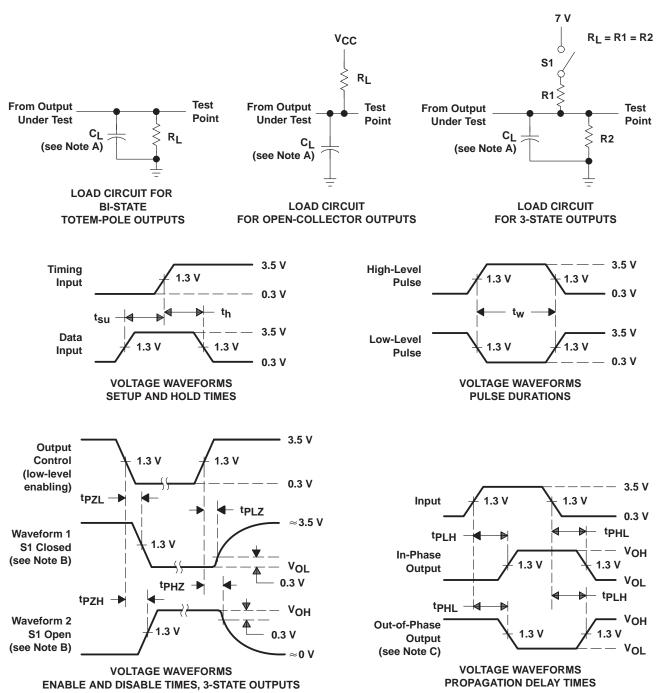

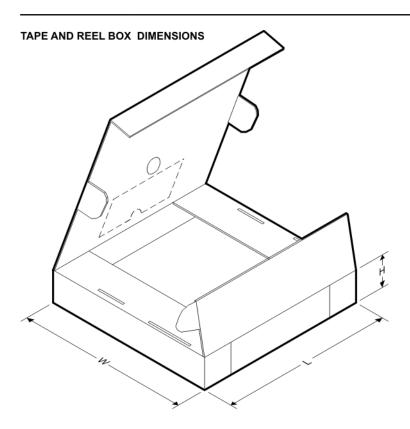
