


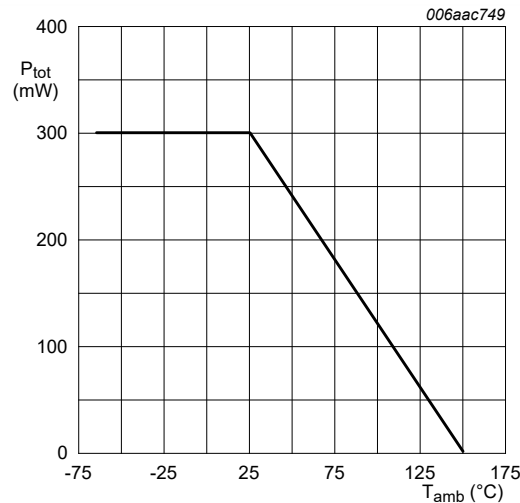

Fig. 1. Per device: Power derating curve

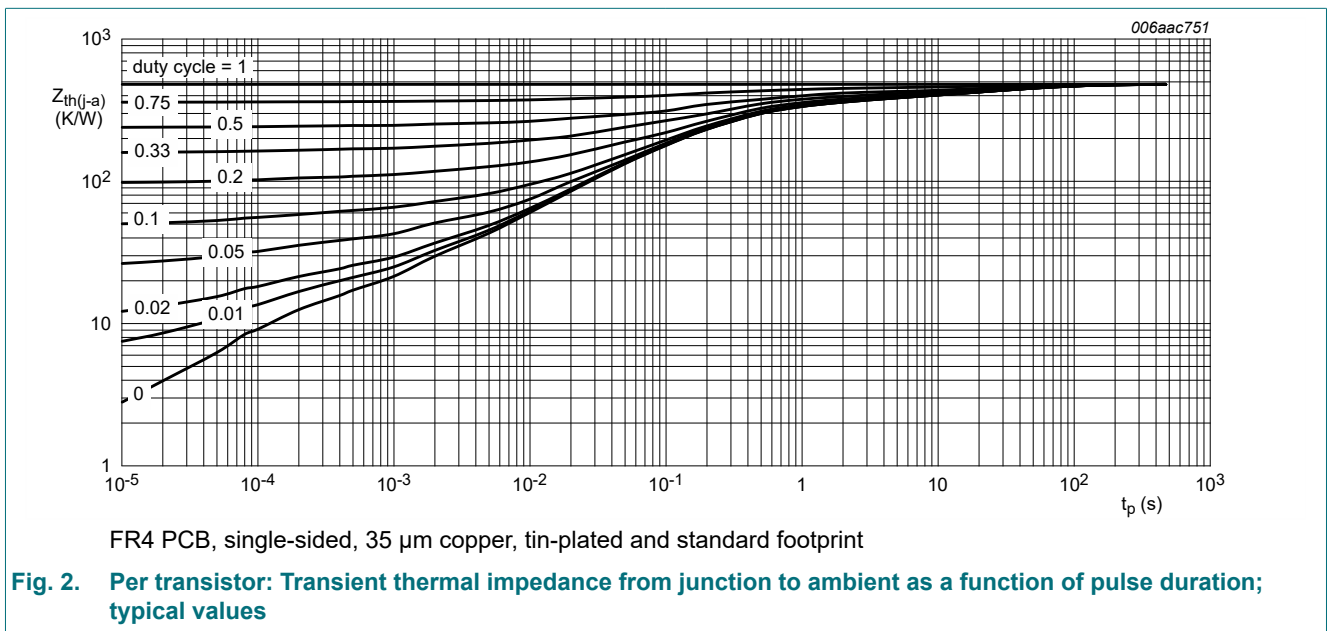

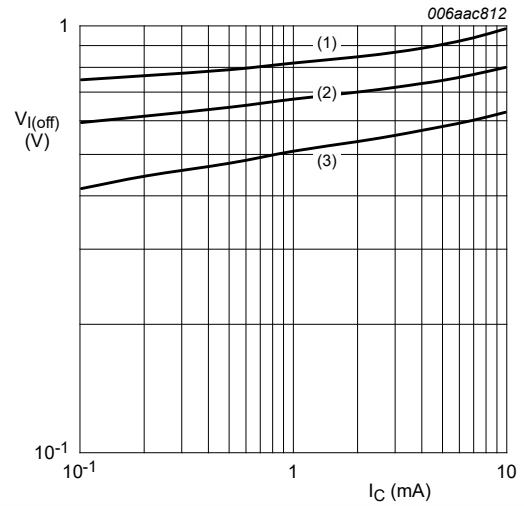

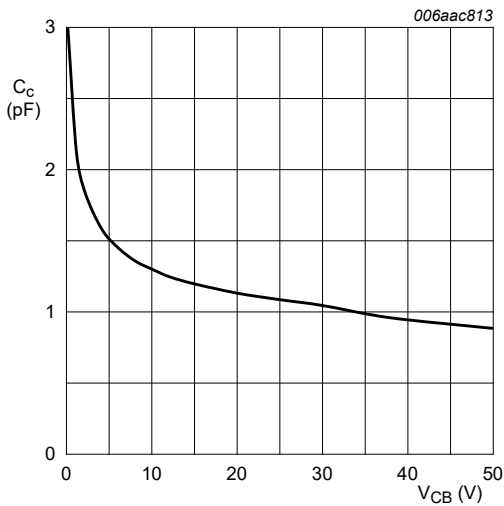

Fig. 5. On-state input voltage as a function of collector current; typical values



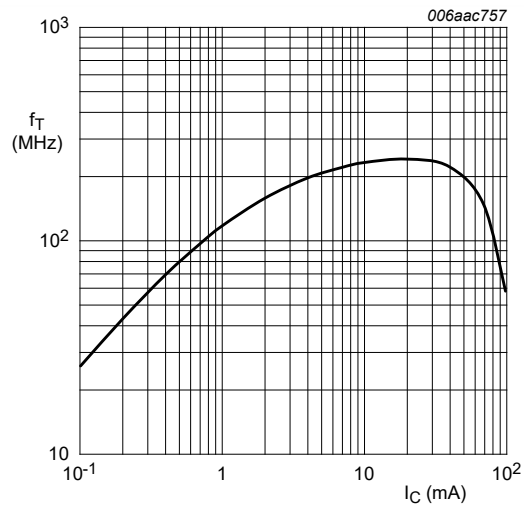

$$\frac{R_2}{R_1} = \frac{V(I_3)}{R_1 \cdot I_3} - 1$$

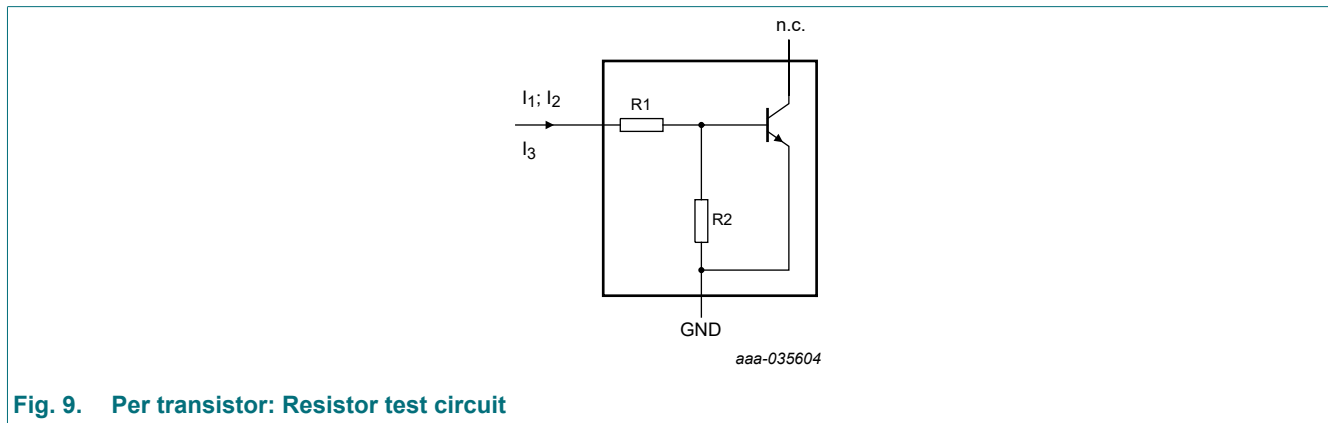


Fig. 9. Per transistor: Resistor test circuit

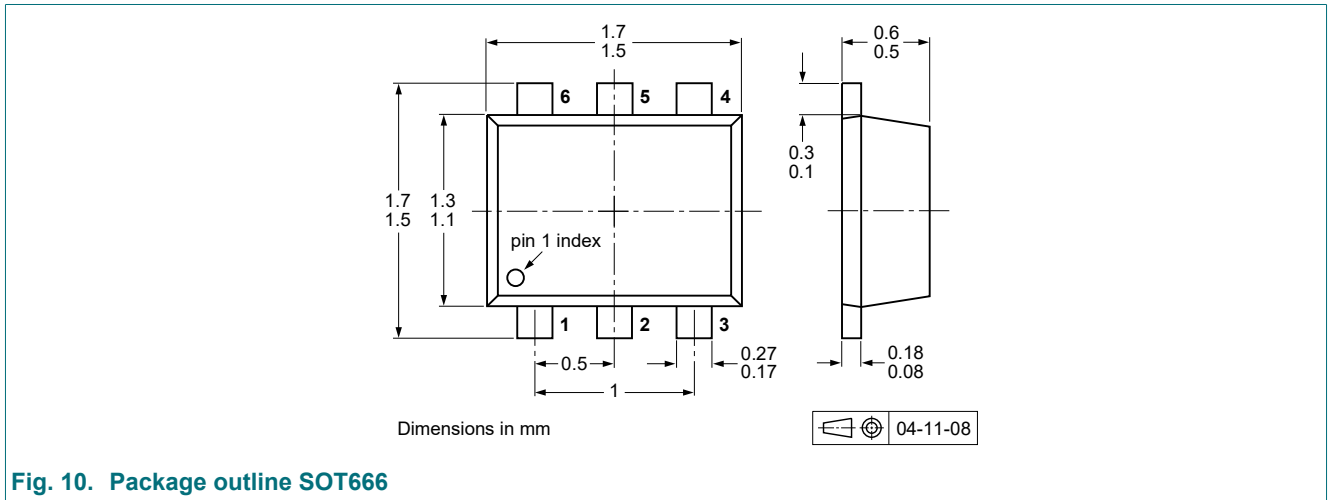


Fig. 10. Package outline SOT666

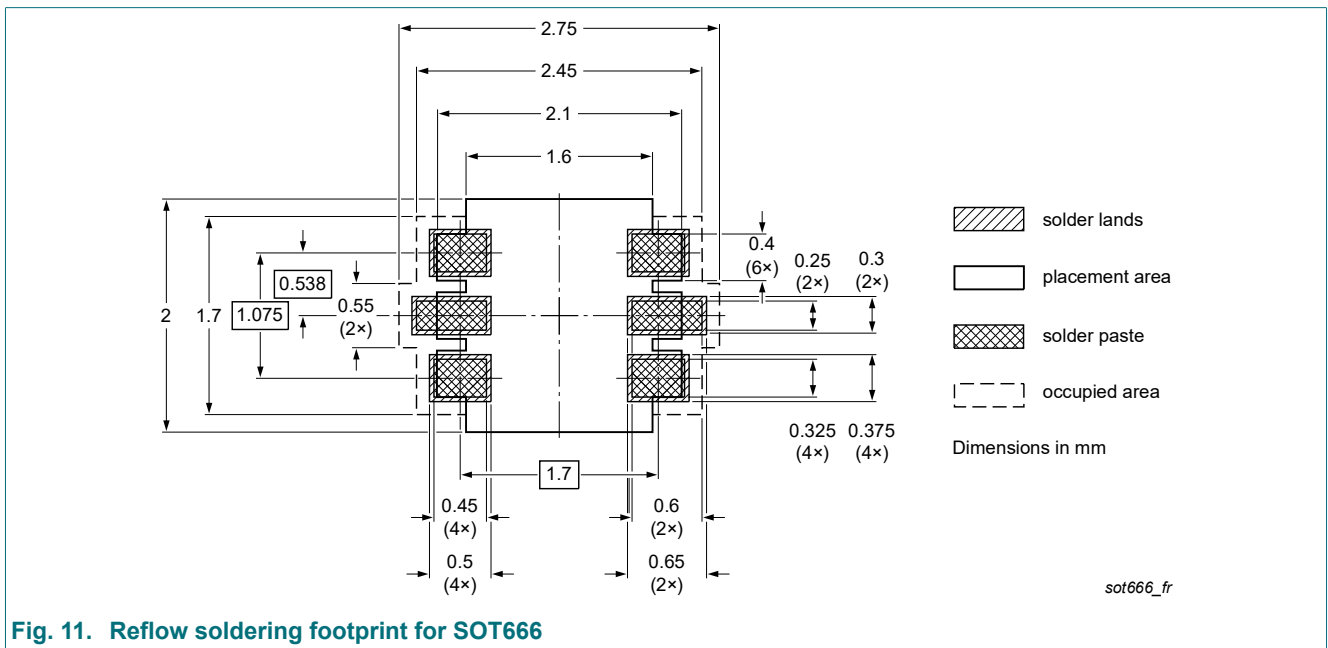


Fig. 11. Reflow soldering footprint for SOT666
