




- The Green source color devices are made with InGaN on Sapphire Light Emitting Diode.

Reflow Soldering Profile For Lead-free SMT Process.




- NOTES:

 2.Don't cause stress to the epoxy resin while it is exposed to high temperature.


 3.Number of reflow process shall be 2 times or less.


Recommended Soldering Pattern (Units: mm; Tolerance: ± 0.1)

Reel Dimension




