



The proprietary barrier technology allows for reliable operation up to 175 °C junction temperature. Typical applications are in switching power supplies, converters, freewheeling diodes, and reverse battery protection.








Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance Z<sub>thJC</sub> Characteristics






Fig. 5 - Maximum Allowable Case Temperature vs. Average Forward Current




Fig. 6 - Forward Power Loss Characteristics




Fig. 7 - Maximum Non-Repetitive Surge Current



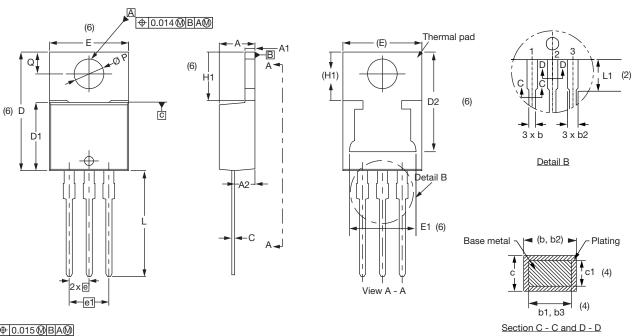

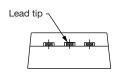
