1. General description

The 74LVC3G17 is a triple buffer with Schmitt-trigger inputs. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




6. Functional diagram












Fig. 12. Package outline SOT505-2 (TSSOP8)




Fig. 13. Package outline SOT765-1 (VSSOP8)




Fig. 14. Package outline SOT833-1 (XSON8)




Fig. 15. Package outline SOT1089 (XSON8)




Fig. 16. Package outline SOT1116 (XSON8)




Fig. 17. Package outline SOT1203 (XSON8)
